

## **TERMS & CONDITIONS**

eNTRI China Terms And Conditions

Visa waiver program is eligible for:

### **PRC Nationals tourist residing in Mainland China except for Hong Kong, Macau and Taiwan**

- This visa waiver program is effective for one year from 1 January 2017 to 31 December 2017.
- An eNTRI Note is only valid for a single journey to Malaysia for the purpose of tourism for the maximum of 15 days each entry without any extension of the period.
- PRC Nationals who are interested to utilize the Visa Waiver Program must register themselves with the Electronic Travel Registration & Information (eNTRI) System either personally or through a travel agency.
- After the applicant has successfully registered for eNTRI, the applicant must print out the eNTRI Note to bring it together to Malaysia.
- Applicants must travel to Malaysia within 3 months after they successfully obtained an eNTRI Note.
- Applicants who are travelling to Malaysia are permitted to enter Malaysia via the following Malaysia Entry Exit points listed below:

#### **By Air**

1. Kuala Lumpur International Airport, Sepang (KLIA & KLIA 2)
2. Penang International Airport, Penang
3. Langkawi International Airport, Kedah
4. Melaka International Airport, Melaka
5. Senai International Airport, Johor
6. Kuching International Airport, Sarawak
7. Miri International Airport, Sarawak
8. Kota Kinabalu International Airport, Sabah

9. Labuan International Airport, Federal Territory of Labuan

**By Land**

1. Sultan Iskandar Building Immigration Checkpoint, Johor
  2. Sultan Abu Bakar Checkpoint, Johor
  3. Padang Besar Checkpoint, Perlis
  4. Bukit Kayu Hitam Checkpoint, Kedah
  5. Sungai Tujuh Immigration Checkpoint, Sarawak
  6. Tedungan Immigration Checkpoint, Sarawak
- Applicants are not allowed to apply any other passes issued under the Immigration Regulations 1963 [L.N 228/1963].
  - The applicant must enter Malaysia by a direct flight from China Mainland to Malaysia or transit via Singapore, Thailand, and Brunei.
  - The applicant also must have a return direct flight ticket to China Mainland, or transit via Singapore, Thailand or Brunei.
  - Upon arrival in Malaysia, the applicant must furnish the following proofs to the Immigration Officers at the Malaysia Entry/Exit points:
    1. eNTRI Note
    2. Boarding Pass
    3. Confirmed tickets coming in and leaving Malaysia
    4. Sufficient funds (Cash/Debit or Credit Cards with UnionPay logo/Travellers Cheque)
    5. Complete travel itinerary
    6. Proof of residence in Malaysia
  - The applicant will be subjected to undergo a three (3) months cooling off period before they can re-enter Malaysia using this Visa Waiver Program.
  - Any applicant who is found to overstay shall be subjected to existing Immigration law in force.
  - Applicant are not allowed to accept any unauthorized employment, or attend

school, or represent the foreign information media during their stay in Malaysia.

- An eNTRI Note does not in any way guarantee the applicant the right to enter Malaysia. The entry is at the sole discretion of the Malaysia Immigration Officer at the entry point. In case of denial entry into Malaysia by the Immigration Officer, VisaMalaysia shall in no way be liable to the applicant in any manner whatsoever.
- Applicants acknowledge and agree that under no circumstances will the VisaMalaysia be liable to them or anyone claiming through them for any indirect, incidental, special and/or consequential losses or damages of whatever nature, or for loss or profits, loss of opportunity, loss of business or goodwill or interruption of business, whether arising out of or in connection with their registration and/or any of the eNTRI registration services, and whether or not relating to any act, error, omission or negligence by the VisaMalaysia or any officer, agent, employee and representative of the VisaMalaysia.
- Applicant who breaches the Malaysian law, will be subject to criminal proceedings and administrative actions by the Government of Malaysia.

### **Other Terms**

- The Government of Malaysia, in its sole discretion, may change, amend, cancel or withdraw any or all of the terms and conditions mentioned herein at any time without any prior notice. If an applicant is dissatisfied with the changes being made, the applicant's sole and exclusive remedy is to refuse the services provided.
- Applicants hereby agrees to accept and confirm that the applicant, prior to submitting the visa application, has read, understood and agreed to be bound by, without limitation or qualification, all of the terms, conditions and details provided herein.
